Terms and conditions of the tender for calibration of radiation monitoring equipments.

Following are the finalized terms and conditions of the tender for calibration of radiation magnitudes equipment.

- Calibration service provider must have valid NABL accreditation and a Lopy of the accreditation certificate must be provided.
- 2. Quotation must be valid till 31.03.2026
- Quotation shall include freight charges for carrying out the equipment to calibration factor, and sending them back to the hospital.
- The calibration service provider will be liable for any damage to the radiation monitoring equipment during transportation and handling.
- 5. The Department will issue the work order for calibration service of each radiation survey meter 4- 6 weeks prior to due date of calibration of that particular radiation survey meter.
- Payment will be released for each radiation survey meter as and when calibration certificate
 for that particular radiation survey meter is generated by calibration service provider.
- 7. Calibration certificate must be valid for 2 years for all the equipments.
- 8. In case, the firm fails to comply with the terms and conditions of the contract or fails to carry out the calibration of the all radiation monitoring equipment available in the department, Lok Nayak Hospital shall be entitled to blacklist the firm or impose suitable penalty as decided by the Competent Authority.
