5. Supplier should have valid drug licence as per D& C Rule 1945 (wherever applicable)
6. Supply of items should be in accordance with the circular no- F.no01/SSH&FW/06/2022/532-536 Dated- 15/03/2024 of VIGILANCE BRANCH, H &FW Deptt. GNCTD (if applicable) . further concerned store keeper is advised to ensure price of the receiving items must not be higher than the MRP
7. Lab reports, e-way bills should be submitted and other caudal formalities should be followed as mentioned in circular dated-15/03/2024 of H&FW Department GNCTD.
