- 1) **TENURE:** The appointment will be initially for a period of 44 days and further extendable for 44 days up to Maximum for 1 year or till the Centralized committee initiate the recruitment process of Junior Resident whichever is earlier subject to satisfactory performance and written request submitted by the individual in this regard duly recommended and forwarded by the concerned HOD at least 15 days in advance and also the performance and good conduct report submitted by the HOD concerned.
- 2) **EXPERIENCE CERTIFICATE:** - Experience Certificate will be issued after furnishing the no dues certificate and assessment report along with 2 (two) passport size photographs on a white back ground, (not applicable for those who leave before completion of 06 months).
- 3) **H.R.A./T.A.:-** As per amendments in Residency Scheme, hostel accommodation is not mandatory. HRA will be paid to Junior Resident only after submitting clearance from Hostel Warden and an under taking declaring that the applicant is not residing in a govt. accommodation allotted to either their spouse or parents.
- 4) **In case of resignation, 10 days advance notice is required otherwise he/she shall be liable to deposit 10 days salary.**
- 5) Salary will only be released after submitting Bank details and obtaining the attendance from the respective department.
- 6) The Candidates who have submitted their application mentioning their experience in Delhi Govt. Hospital, their employee ID should be **transferred without NPS on DDO code -043001 of Lok Nayak Hospital**. This may be ensured by the selected Junior Resident.
- 7) **In case, details of earlier work period /experience found to be false, the hospital Administration is at liberty to take deemed fit action against concerned doctor or terminate their service on the same day.**
- 8) **Leave: Junior Residents are entitled for 2 ½ days leave for one complete calendar month, i.e., (1 to 31 full month) and no leaves shall be carry forwarded . No leave other than this will be granted.**
- 9) The appointment is further subject to the following:-

- b. He/She is required to submit a declaration to the effect that he/she is not having more than one living spouse.
- c. On appointment, he/she shall be required to take an oath of allegiance to serve any department of the hospital.
- d. He/She is required to explicitly state whether he/she is serving or under obligation to serve any other Central/State Govt. Department or a Public Authority.
- e. The other condition of service will be governed by Residency Scheme.
- f. Production of self attested copies of Educational/Technical Qualification, Caste Certificate etc.
- g. He/She is required to submit an undertaking that no criminal investigation is ensuing or pending against him/her in the court of law/investigating agency.
- h. If any declaration given or information furnished by him/her proves to be false or if he/she is found to have willfully suppressed any information, he/she will be liable to be removed from service and such other actions as Government may deem necessary. He/she is directed to accept the offer of appointment w.e.f. **29.07.2026 to 06.08.2026 between 10.00 Am to 12:00 Noon** with their necessary original documents, failing which it will be presumed that he/she is not interested in the offer and the offer of appointment will be treated as cancelled. **No requests for extension for joining shall be entertained.**
