Applications are invited for filling up the vacant posts of Junior Residents in Lok Nayak Hospital, New Delhi on regular basis for a period of one year. The appointment shall initially be for a period of six months but extendable upto one year on the basis of satisfactory work and conduct report from the concerned HOD and written request received from the JR concerned and subject to availability of vacancies.

ELIGIBILITY CRITERIA FOR THE POST O F JUNIOR RESIDENT (MBBS):-

- Qualifications: MBBS degree from recognized University/Institute. Candidate should not have completed one year Junior Residency from any Govt. Hospital.. However, no candidate shall be eligible, in any case, if he/she already had completed 02 years residency in any Government Hospital under the Residency Scheme.
- Age Limit:- As on 01.07.2020 shall be 30 years for General and EWS candidates, 35 years in case of SC/ST and 33 years in case of OBC candidates. However, if sufficient no. cf eligible candidates as per this criteria are not available, the relaxation as per Circular No. F.No.121/26/2010/H&FW/OSHFW/1996-2045 dated 10.06.2011 of Government of NCT of Delhi shall be admissible and the maximum The General and EWS Committee of category.
- III. The General and EWS Candidates who are born before 01.07.1990, SC/ST who are born before 01.07.1985 and OBC category candidates who are born before 01.07.1987 are not eligible under normal circumstances. However, under the relaxed conditions, even those born prior to above dates shall be eligible. But those candidates, born earlier than 01.07.1980 shall not be eligible in any case.

DMC registration and experience certificate, if any, for verification at the time of interview. Those who do not possess valid DMC registration certificate need not apply. Acknowledgement from DMC will not be accepted under any circumstances.

Junior Residents who have completed one year of Junior Residency shall also be allowed to appear in the interview and will be offered residency on adhoc basis only if fresh candidates for the post of Junior Residents are not available. Extension of any Junior Resident beyond one year of appointment will be made under accordance relaxed provisions in No.F.No.121/26/2010/H&FW/1996-2045 dated 10.06.2011 and their extended tenure will be on adhoc basis (89 days) for a period of 1 year.
- Those candidates who are working in LNH and have completed one year of Χ. residency need to apply afresh.
- No TA/DA shall be paid to candidates who are appearing in the interview. XI.

- There is no fee for appearing in the interview. XIII.

- 1. Junior Resident(s) are entitled for 21/2 days leave for one complete calendar
- 2. month. No leave other than this will be granted.
- 3. LTC, Pensionary benefits, Group Insurance, Study Leave and Child Care Leave are not admissible. However, Maternity leave will be granted as per the provisions of the Maternity Benefits (Amendment) Act 2017, to the appointed female Junior Residents.
- 4. The reservation in vacancies will be as per prevailing rules endorsed by Govt. of NCT of Delhi.
- 5. The contract may be terminated by either side with one month's notice or salary in lieu thereof. The selection is purely on tenure basis and does not confer any right for regularization or permanent absorption.
- 6. Private practice of any kind is not allowed.
- 7. Other conditions of service shall be governed by the orders issued/endorsed from time to time by Government of NCT of Delhi.

Jurisdiction of Dispute: In case of any legal dispute the jurisdictions of Courts will be Delhi/New Delhi only.
