#### OFFICE MEMORANDUM

Sub: One time regularization policy through relaxation in age to the contractual Nursing & Paramedical employees working under H&FW, GNCTD at the time of regular appointment on direct recruitment basis.

The issue with regard to One-time regularization policy through relaxation in age limit to contractual Nursing and Paramedical employees under H&FW, as a onetime measure, in direct recruitment has been examined in the light of WPC-6798/2002 titled Sonia Gandhi & Ors. Vs GNCTD & Ors., opinion of Standing Counsel, in consultation with Law and Services Department.

The Competent authority is pleased to order to fill-up the posts as per recruitment rules and contractual Nursing and Paramedical employees hired against those regular posts may be given age relaxation as per the following modalities to be adopted in respect of Contractual Nursing and Paramedical employees under H&FW, GNCTD.

- I. The contractual Nursing and Paramedical employees who were working as contractual employees under H&FW as on 26.11.2013 (date of order passed by Hon'ble High Court in WPC-6798/2002) and as on date are still continuing (as per extension given for year 2020-21) their service as contractual employee under H&FW Department are eligible for this age relaxation.
- II. The contractual employees should have worked at least 180 days in a
- III. The contractual employees under H&FW can apply only one time (without any age bar) in direct recruitment of their respective posts as and when next time DSSSB issue a notification for regular appointment on direct recruitment
- IV. Only those contractual employees who were employed (at the time of their appointment on contractual basis) against regular sanctioned posts under H&FW Department are eligible for this relaxation.
